

Terms and Conditions for being a stallholder.

The Maitland Community Markets are organised and managed by the Hunter River Agricultural & Horticultural Association Limited (HRA&HA Ltd)

The following terms and conditions apply to all stallholders.

- 1. All fees must be paid in advance prior to the market day
- 2. The HRA&HA Ltd reserves the right to refuse any application from a stallholder for any reason it sees fit and does not need to divulge the reason for doing so.
- 3. Cancellation of a site can be done up to 10 days prior to the event without penalty. No credit or refund will be provided for any cancellation less than 3 business days prior to the event.
- 4. Where the HRA&HA Ltd cancel the event for any reason, a refund of the site fees paid or a credit towards future markets will be honoured.
- 5. Anti-social or abusive or offence language or behaviour will not be tolerated and any offending stallholder in the opinion of the HRA&HA Ltd may be removed from the markets and not allowed to return.
- 6. Stallholders must remain on the site they are allocated and not encroach on any adjoining site or space.
- 7. If there is a dispute, the stallholder must advise the manager of the market as soon as practical and preferably in writing by email address to manager@maitlandshowground.com.au.
- 8. Stall sites cannot be sublet or transferred to another stallholder.
- 9. Gazebos, marquees and umbrellas must be properly secured.
- 10. Stallholders must observe all safely obligations, in particular vehicle movements including not exceeding the designated speed limit of 10kms per hour with warning lights activated. The movement of vehicles, without the supervision of the market management must not occur after 8am and before 2pm on market day.
- 11. Unless you have permission to have your vehicle behind your stall, you must remove your vehicle to the stallholders carpark as soon as you have unloaded and by 8am at latest.
- 12. All rubbish to be removed by stallholders including cardboard and cable ties. If rubbish left behind additional charges will apply.
- 13. All stallholders must comply with the current COVID safe requirements in force at the time of each market. Please provide sanitiser at your stall and ask visitors to observe the social distancing requirement (1.5 metre rule) when approaching your stall.
- 14. A site may be requested however may not be available due to other requests for the same site

15. Permanent Stallholders

a. Permanent sites are now available to be requested under the new booking system. To be a permanent stallholder and allocated a permanent site, you MUST pay and attend all markets and be on your site by 7am each market. Maitland Community Markets reserve the right to temporarily assign a permanent site to a casual stallholder after 7am on any market if a permanent stallholder does not attend. Permanent stallholder status will be revoked if you fail to attend on two (2) occasions in a calendar year, may

- result in the site being allocated to another stallholder. The decision to grant permanent stallholder status is at the discretion of the Maitland Community Markets management.
- **b.** In the interests of hosting a successful market, Maitland Community Markets management reserves the right, after consultation, to move any permanent stallholder to another site where they see fit for the benefit of the Markets, other stallholders or the general public. Stallholders cannot 'demand' their 'usual' site. In the instance where a permanent stallholder is to be moved, they will be notified via email or phone.
